Rules for fishing at the Pit

- 1. Fishing is restricted to permit holders only for the season of 16th June to the 31st January. No fishing is permitted at other times for the protection of the Pit ecology and those fishing.
- Permits are restricted to schoolchildren under the age of 16 years who are resident in Christleton Parish and are holders of an Environment Agency rod licence (tel. 0800 169 2103). This licence is not required for children under 12 years of age.
- 3 Permits cost £5.00 per season and applications forms can be obtained from the Village Shop and the Ring 'O' Bells.
- 4 The permit must be carried at all times and must be available for inspection by any authorised agent of Christleton Parish Council.
- 5 Permits are not transferable. The Parish Council reserves the right to withdraw any permit for any failure to comply with any of these conditions.
- 6 No fishing between sunset and sunrise.
- Fishing is permitted from the 2 platforms only (see plan). Anyone found to be fishing in other restricted areas will have their permit revoked.
- 8 Max 2 rods per person. No lead weights or barbed hooks. Max hook size 10
- 9 No surface fishing due to risk to bird life
- 10 Suitable landing net and mat to avoid injury to Carp.
- 11 Every care must be taken to prevent damage to banks or associated trees and bushes.
- All litter, including discarded tackle, hooks, etc. is to be removed from the Pit and its surrounds after fishing.
- Any discarded fishing tackle, hooks, etc. which cannot be retrieved and any injury to birdlife or entanglement of birds with fishing line

- must be reported immediately to one of the telephone numbers given below.
- 14 Those fishing to be aware of, and take sensible precautions with regard to waterborne diseases. Any person fishing at the Pit does so entirely at his/her own risk. The Parish Council does not accept any liability for any loss, Damage, illness, injury or death howsoever caused.
- The Pit and surrounding area are designated an Alcohol Free Zone. No consumption of alcohol is permitted.

The Parish Council is working with the Police Authority and Environment Agency to ensure compliance with these conditions.

The local community has been made aware that any person may report any problem to Police tel. 0845 458 000, 101 or 999 if illegal behaviour is occurring.
